

INFORMATION ABOUT THE PROCESSING OF PERSONAL DATA - COOKIES

provided under Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) ("GDPR Regulation"), and under Act No. 110/2019 Coll. on Personal Data Protection, and amendments of certain Acts ("Personal Data Protection Act").

IDENTIFICATION OF THE DATA CONTROLLER

WHAT ARE COOKIES?

We use cookies to improve the services offered to visitors of our website. A cookie is a small text file that a website stores on your device (e.g., computer, laptop, or smartphone) via your web browser when you visit a website. Cookies ensure safer and faster interactions by storing user preferences and transmitting them back to the website of origin (first-party cookies) or to another website (third-party cookies) that recognizes them. Cookies are used to facilitate and improve your experience on our websites. To create statistics and better understand visitors' needs, we use Google Analytics and Hotjar. Cookies are also used for targeted advertising through Google and Meta Platforms tools, aiming to deliver offers that may be of interest to you. Since some cookies can potentially identify individual website visitors, such cookies are considered personal data subject to data protection laws.

MANAGING COOKIE SETTINGS

CORWIN CZ s.r.o. processes (A) strictly necessary technical cookies (so-called "necessary" cookies), which are essential for the operation and usability of the website; and (B) optional cookies, which can be processed based on the consent of the website visitor. When visiting our website, you will be informed about the types of cookies we use. In addition to the strictly necessary technical cookies (i.e., necessary cookies), which are indispensable for using the website, we request your consent for the use of optional cookies through our cookie popup window. Please note that strictly necessary cookies will be processed regardless of your preferences, as their processing is based on legal requirements.

Through the cookie popup window, you can grant or refuse consent for the use of cookies or set your preferences regarding the collection and processing of cookies, taking into account the specific purposes of their use. You can grant consent by clicking the "ALLOW ALL" button or refuse consent by clicking the "DECLINE ALL" button. Until you provide specific consent, we will not process your data within the scope of optional cookies.

If you choose to select which cookies you want us to process about you, you can do so by clicking the "CUSTOMIZE" button, selecting the categories of cookies you agree to, and then confirming your choice by clicking the "ALLOW SELECTION" button. The cookie consent popup will appear during your first visit to our website and will subsequently be displayed

only if changes occur (e.g., a third-party cookie is added to the cookie list, or the legal basis for processing personal data is modified). Otherwise, the banner will only reappear at reasonable intervals, depending on the set duration for the strictly necessary technical cookies specified below.

You can change your decisions at any time by accessing the cookie settings window via the round icon in the bottom left corner of our website. Through this icon, you can revoke your previously granted consent or modify the settings of that consent.

WITHDRAWAL OF CONSENT FOR THE COLLECTION AND PROCESSING OF OPTIONAL COOKIES

You may withdraw your consent for the processing of personal data at any time, and such withdrawal does not affect the lawfulness of processing carried out prior to the withdrawal. You can change your decisions at any time by accessing the cookie settings window via the round icon in the bottom left corner of our website, through which you can revoke your previously granted consent.

You can also block or delete cookies via your web browser or third-party software; however, certain parts of the website may encounter issues, and the user experience might not be as smooth.

As a data subject, you also have the right to object to the processing of personal data when such processing is based on legitimate interest or for direct marketing purposes.

CONFIGURATION OF THE WEB BROWSER

If you wish to delete cookies stored on your devices and configure your web browser to reject cookies, you can do so by adjusting the preference settings of your web browser. For more information, please visit the relevant webpage of your browser. However, we would like to inform you that, in such a case, you may need to manually adjust certain settings each time you visit the website, and some services and functionalities of the website may not operate properly.

WHAT COOKIES DO WE USE AND HOW LONG DO WE PROCESS PERSONAL DATA?

On our website, we use the following categories of cookies:

- 1. Necessary Cookies** – Necessary cookies help make websites usable by enabling basic functions such as page navigation, access to protected areas of the website, and ensuring website security. Websites cannot function properly without these cookies, and they are therefore essential for the use of our website. **The legal basis for processing these cookies is Article 6(1)(c) of the GDPR – a legal obligation under Act No. 452/2021 Coll. – and legitimate interest under Article 6(1)(f) of the GDPR.**
- 2. Statistical Cookies** - Statistical cookies help CORWIN CZ s.r.o. understand how to communicate with website visitors by collecting and reporting information anonymously. **The legal basis for processing these cookies is Article 6(1)(a) of the GDPR – the consent of the data subject.**
- 3. Marketing Cookies** - Marketing cookies are used to track visitors across websites. The purpose is to display advertisements that are relevant and engaging to individual users, making them more valuable to publishers and third-party advertisers. **The legal basis**

for processing these cookies is Article 6(1)(a) of the GDPR – the consent of the data subject.

On our website, we use tools provided by Google, Meta Platforms, and Hotjar. The privacy policies of these companies, as well as the duration of data processing, are available on our website directly in the cookie settings interface. You can review these policies in a clear form before giving your consent and can return to this information at any time by triggering the cookie settings window by clicking the round icon at the bottom left of our website.

LEGAL BASIS AND PURPOSE OF PERSONAL DATA PROCESSING

1. **Necessary cookies** – compliance with a legal obligation pursuant to Article 6(1)(c) of the GDPR and legitimate interest pursuant to Article 6(1)(f) of the GDPR
2. **Statistical cookies** – consent of the data subject pursuant to Article 6(1)(a) of the GDPR
3. **Marketing cookies** – consent of the data subject pursuant to Article 6(1)(a) of the GDPR

The purposes of processing your personal data are:

- fulfilling legal obligations related to the operation and security of the website;
- raising awareness of our company and products in the online environment (via social media and our company's website);
- improving the functionality of the website in response to the needs of its users.

The legitimate interest of CORWIN CZ s.r.o. for processing necessary cookies is primarily the company's interest in operating the website and maintaining its security and basic functionality, including the interest in defending its rights in connection with a security breach or other interference with the website.

In the case of personal data processing based on the legitimate interest of CORWIN CZ s.r.o., the data subject has the right to object to such processing at any time. In such cases, CORWIN CZ s.r.o. may not continue processing the personal data unless it demonstrates compelling legitimate grounds for the processing that override the interests, rights, and freedoms of the data subject, or the grounds for establishing, exercising, or defending legal claims.

RECIPIENTS OF PERSONAL DATA

Personal data is provided or made accessible only to the extent necessary to the following recipients or categories of recipients:

- entities providing IT services and support to the company;
- external entities responsible for the company's marketing communications;
- providers of statistical tools placed on the website (Google, Hotjar);
- providers of marketing tools placed on the website (Google, Meta Platforms);
- law enforcement authorities, courts, and other public authorities in the event that CORWIN CZ s.r.o. is required to provide such data or when it is necessary for the purpose of asserting its legal claims.

The recipients are obligated to process your personal data exclusively for the purposes described in these terms. Your data is not made available to third parties for their independent use or processing beyond the purposes outlined in these terms.

The conditions for the processing of personal data by certain recipients are detailed below in the category "Cross-border Transfer of Personal Data."

RIGHTS RELATED TO THE PROCESSING OF PERSONAL DATA

Subject to compliance with the conditions set forth by the legal regulations governing personal data protection, you, as the data subject, have the following rights:

As a data subject, you have the right to request access to personal data, the right to rectification of personal data, the right to erasure of personal data, the right to restriction of personal data processing, the right to object to the processing of personal data, as well as the right to data portability.

If you, as a data subject, believe that your rights under the GDPR Regulation or other applicable personal data protection laws have been violated, you may, of course, contact us or have the right to file a complaint with the Office for Personal Data Protection of the Czech Republic.

NECESSITY OF PERSONAL DATA PROCESSING

It is entirely up to you how you set your cookie settings when browsing our website and whether you consent to processing beyond the basic functionality of the website (i.e., beyond the so-called necessary cookies). Providing consent is not a legal requirement, and if you do not grant consent, it will have no consequences.

INFORMATION REGARDING AUTOMATED INDIVIDUAL DECISION-MAKING

CORWIN CZ s.r.o. does not use any automated individual decision-making processes or profiling in the processing of your personal data.

CROSS-BORDER TRANSFER OF PERSONAL DATA

In general, we strive to configure personal data processing in a way that personal data is not transferred to third countries outside the European Economic Area (EEA).

However, particularly for communication with our online audience, we also use services from some leading providers, such as Google, Meta Platforms, and Hotjar. These providers of analytical or marketing tools may be based, or their servers may be located, in countries such as the USA, which are outside the EU.
